**To ensure correct measurements have them taken by a professional and have them taken under clothing**

<b>Bust</b>	Bust measurement around fullest area around the breast (NOT your bra size)	
<b>Waist</b>	Waist measurement at center of the torso is your natural waistline (where you bend)	
<b>Hips</b>	Hip measurement approx. 9" down from the waist at the fullest part of your bottom	
<b>Length</b>	Either Waist-to-floor ~ measurement was taken with a) <u>heels on</u> or b) <u>flat-footed</u> or Shoulder-to-floor ~ measurement was taken with a) <u>heels on</u> or b) <u>flat-footed</u> Minus 1" allowance for hem = total length	
<b>Heel Height</b>	Heel height is necessary if measured flat-footed to determine skirt length; shoe heel measurement is taken from the inside of the heel, not down the back of the shoe	
<b>Shoe Size</b>	We recommend ordering $\frac{1}{2}$ size larger for shoes that will be dyed to match the dress
